Members are drawn from all areas of the care catering industry. The catering may take place in residential homes or day care for people with disabilities the elderly or young people. It also encompasses the delivery and production of fresh or frozen meals to day centres or peoples homes.

The NACC has six established regions across the United Kingdom to facilitate easy access to local meetings. Regional meetings are held three times a year and are an eclectic mix of information, feedback, training, an opportunity to share knowledge, participate in forums and of course all in a relaxed enjoyable atmosphere. As the NACC is a member organisation there are ways for you to participate and be involved with the future shape of the NACC and care catering.

Types of membership

Individual membership – £67 excluding VAT

Open to any individual engaged in any aspect of catering within the care sector. Individual members may attend meetings in any region but may only vote in the region to which affiliated. May hold national or regional officer posts.

Corporate membership – £245 excluding VAT

Open to any company or other organisation engaged in any aspect of catering within the care sector. Corporate membership includes up to four members, each of whom may attend meetings in any region. However, Corporate members are only entitled to one vote and only one member may hold office in the NACC.

Retired membership – £33.50 excluding VAT

Open to any Individual member who has retired from normal employment. May attend meetings in any region but may only vote in the region to which affiliated. May hold national or regional officer posts.

Student membership – no fee

Open to any individual undertaking any course of study leading to a qualification in the catering industry. No voting rights. Not permitted to hold national or regional office.
